HOW DOES IT WORK?

By now you probably realised it is extremely hard to register and insure a vehicle in Europe, then, renting is way too expensive and even when you bypass the insurance and rego, you still need to sell the vehicle after your holiday. The Buyback is the ultimate middle way between renting, and purchasing a vehicle.

How does it work?

- You purchase a RV through us with a guaranteed buyback price.
- We will register and insure the vehicle. It will be registered on our company name while the costs will be forwarded to you.
- Upon your arrival, the vehicle will be checked, serviced and ready for your journey.
- You start your travels with your own vehicle.
- During your travels you are liable for the vehicle however due to mutual benefits tend to discuss when problems occur.



- When you return the vehicle we expect to get it back as you received it from us.
- Damages will be deducted of the buyback price.
- When everything is in order, we sign the papers and return the buyback price in the following weeks.

When returning the vehicle we will check it for damage and sign the papers, then return your discussed buyback price in the following weeks.



OWNING AVEHICLE

The vehicle will be registered on the Europe-Roadtrip.com company.

Liability

During your roadtrip, you are responsible for the vehicle like if you purchase something in your own country. Most vehicles are being sold with no warrantee which means that you are the acting owner of the vehicle at any stage of your trip.

Restrictions

The only contractual restrictions are a flexible milage limit that is based on your period and vehicle

Country restrictions

Besides ukraine or liable countries, most countries are okay to travel for. The UK, Turkey or Serbia are all ok.



TERMS & CONDITIONS

Mediation contract between you (buyer) and Harro (mediator)

Contract

The buyer is liable for the vehicle and is acting as the owner of the vehicle in any circumstance besides failure of payments or failure to deliver the vehicle in the expected period.

The contract states a kilometre limit based on the service periods due. extra mileage can always be bought by the buyer or discussed with the seller.

The buyback price is based on full periods which means there is no difference between the buyback price when you deliver early unless it is discussed with the seller. extra costs can be charged when selling it back after the discussed period.

The downpayment is used for service and securing the vehicle, it will not be returned upon cancelling the trip, however, in agreement with the seller, it can be used for future periods.

The buyer is responsible for the acceptance of the vehicle upon arrival, it's the buyer's responsibility to check whether the vehicle is up to the buyer's standard.

Finally, the repurchase price will be based on the discussed buyback price minus the overdue payments, or damage, fines or other costs made by the buyer.

Insurance claims will be held with a \in 2000,- excess per damage.

Fines or violation tickets will be paid with a € 25,- administration fee and sent to you by separate invoice.

The vehicle is registered in the company's name. it will be either registered on our German Company Camperfun GmBh or on the Dutch company Europe-Roadtrip.com under the name or Harro Mulder.





ER WARRANTY

Warrantee can be bought for ${\bf \in 900, -}$ prior to departure.

Includes

Warranty includes only specific parts of the vehicle, it can be used when the engine fails or turning parts of the engine fail. it will also be considered warrantee when fabric build gear of the vehicles fails, such as the Fridge, Boiler, Heating, Water pump, frost security, charger or control panel. it will not include add-ons, manual used parts such as curtains, taps, hatches or others. It will also not include engine parts that are part of the MOT APK in NL or TUV in Germany such as tires, brakes, filters or add-ons, for more information on what includes a TUV or APK we trust the buyer can do research online or ask us specific questions.

Restrictions

The warranty will be € 900 euro paid prior to departure. It will last for 3500 km after departure or 3 months after leaving with the RV, whichever one expires first. Warranty includes the possibility of repair at the Europe-Roadtrip.com approved garage or own location. The customer will be held responsible for rip-offs and will in all moments discuss costs and warrantee options with the warranty giver. fixed prices and quotes will be used as reference to refund warranty repairs. The customer is asked to pay in advance and send the invoices for warranty to refund.

Invoices will be named on the company details and will be sent in digital form to info@europeroadtrip.com. Warranty does not cover the costs of towing, hotel costs nor difference in travel periods. it is the responsibility of the warranty taker to get the vehicle in safety and extra damage caused because of incidents is not considered a warranty. For other issues that not included in this document, we will expect the warranty taker to discuss them with Europe-Roadtrip.com based on a good business relation between buyer and seller.

Roadtax and Insurance

The monthly costs of roadtax and the emmision fee are between € 95,- and € 110,- the costs for a basic insurance costs € 135 per month, and a full comprehensive insurance costs € 385,p/m


